



## LIMITED LIFETIME WARRANTY

PREMIUM DISTRIBUTION warrants that its SUMMUM/SUMMUM PRO stainless steel chimney systems are free from malfunctions due to defective materials or workmanship as long as the original consumer owns the chimney system. This warranty covers the replacement of all components that are found to be defective as a result of normal use on a residential fireplace, stove, wood stove, wood furnace or boiler and includes the replacement of all sections damaged as a result of a chimney fire. These chimneys are designed to evacuate combustion gases from residential heating oil, untreated wood, pellets, low-sulphur coal and natural or propane gas. They are designed to operate at a maximum continuous temperature of 650° C (1200° F) or less. They are not designed for the use of equipment that condenses with oil or gas. This warranty is void if the chimney is used for an application for which it is not designed (Note: this warranty is void if the chimney is not installed in accordance with the included installation instructions and local and national building codes). In the case of a chimney fire, the chimney must be inspected and approved by a certified chimney sweep before use. Chimney fires are dangerous and preventable. We strongly recommend that you clean your chimney regularly according to the installation instructions.) PREMIUM DISTRIBUTION ensures that all stainless steel chimney components are resistant to perforation and corrosion. This warranty does not cover damage to the building caused by chimney fires or improper use of the product. No claim under this warranty will be honored unless PREMIUM DISTRIBUTION is notified of a potential claim and PREMIUM DISTRIBUTION will not be held responsible for the repair or replacement of defective components under warranty. In no event shall PREMIUM DISTRIBUTION be liable for damage to accessories indirectly caused by defects in the SUMMUM/SUMMUM PRO chimney system. During the first ten years of the warranty, PREMIUM DISTRIBUTION will provide chimney replacement components at no charge. During the remainder of the warranty PREMIUM DISTRIBUTION will provide replacement of chimney components at 50% of the current retail price at the time of the warranty claim.

PREMIUM DISTRIBUTION shall not be held responsible for work of any nature necessary to remove or replace a SUMMUM/SUMMUM PRO chimney system replaced under this warranty, nor for the transportation or return of a product, or the transportation of a replacement product. SUMMUM/SUMMUM PRO chimney systems must be installed according to the Installation Instructions provided with each system at the time of purchase. Installation must be performed by a qualified APC professional member or a WETT certified professional. After each inspection, maintenance and cleaning, the certified chimney sweep must indicate the date and nature of the work performed on the warranty card provided with the chimney system. ### WARRANTY EXCLUSIONS

- A. Any non-stainless unit mounted or connected to the base of the Tee to an insulated chimney system;
- B. Damage to the finish of products caused by the use of improper solvents/chemicals or improper (or lack of) cleaning methods
- C. Damage resulting from normal wear and tear, smoke damage or damage caused by chimney fires or failure to reasonably clean, care for or maintains products in accordance with our installation instructions/recommendations



- D. Damage (products, appliances or structure) based on or resulting from improper installation or repair, misuse or abuse (including, but not limited to, excessive or inappropriate conditions of use), or alteration of adjustments other than those in accordance with our specifications and assembly instructions, whether performed by a contractor, technician, a service provider, any other person or yourself
- E. Any products that have been moved from their original installation site
- F. Damage caused by the combustion of driftwood, waste or any other prohibitive material that has been burned in the appliance served by the chimney
- G. Damage resulting from accidents such as fires, floods, high winds, "act of god" or any other event beyond our control.

CLAIM PROCEDURE: If you believe that a product is defective, notify us in writing at:

PREMIUM DISTRIBUTION must be notified of the possibility of inspecting the defective product before replacement under the terms of this limited lifetime warranty. The notification must include proof of purchase, a description of the product and a brief description of the problem. Upon receipt of a written request under this limited warranty and proof of purchase or installation, at our discretion and at our sole discretion, we will provide the replacement product excluding any work, delivery, and installation costs. We reserve the right to inspect or investigate any warranty claim before determining whether to provide a replacement product. If, as determined by PREMIUM DISTRIBUTION, repair or replacement of the product is not commercially possible or cannot be completed within a reasonable delay, we reserve the right to refund the price paid on the initial purchase of the product by providing a copy of the invoice/proof of purchase.

Notwithstanding any other term or condition of this lifetime warranty, if these products are not installed by a qualified professional installer, PREMIUM DISTRIBUTION does not give any warranty for the products: a qualified professional installer is defined as one of the following: must have a contractor's license with prior chimney installation experience, an APC Certified installer, or a WETT certified professional.

LEGALLY, PREMIUM DISTRIBUTION DISCLAIMS ALL OTHER WARRANTIES, INCLUDING BUT NOT LIMITED TO THE IMPLICIT WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE. IN NO EVENT SHALL PREMIUM DISTRIBUTION BE LIABLE FOR ANY DIRECT, INDIRECT, PUNITIVE OR SPECIAL DAMAGES OR DIRECT OR INDIRECT LOSS OF ANY KIND, INCLUDING BUT NOT LIMITED TO PROPERTY DAMAGE AND PERSONAL INJURY. ANY LIABILITY FOR PREMIUM DISTRIBUTION IS LIMITED TO THE PURCHASE PRICE OF THIS PRODUCT.
